JUDGEMENT

According to §31 of the German Food and Feed Code (Lebensmittel- und Futtermittelgesetz, LFGB) and the European Framework-Regulation VO (EC) No. 1935/2004 food contact materials may not release substances in food or its surface in quantities that could

1. endanger human health
2. bring about an unacceptable deterioration of the composition or the organoleptic properties (smell, taste) or the appearance of food (e.g. colour)

According to Recommendation XXI of BfR (Federal Institute for Risk Assessment) for natural and synthetic rubber for food contact (as of 01.07.2015) chapter 2.2 category 2 the overall migration may not exceed 20 mg/dm² for simulant water and 10 % ethanol and 100 mg/dm² for 3% acetic acid.

- Simulant water - below limit value
- Simulant 10% ethanol - below limit value
- Simulant acetic acid - below limit value

In the scope of the analyses performed and under the above test conditions there was no indication for an objection.
